Federal Contracts - Goodwill Specialty Services Inc. (GSSI) provides employment opportunities through contracts with separate government entities of the Federal Government. These are set aside contracts for people with severe disabilities through the Javits-Wagner-O'Day act of 1971. GSSI is currently engaged in custodial, postal services, and grounds maintenance contracts through this program. Employees are paid through a management and administrative services contract with Goodwill Industries Inc. In 2010, GSSI was responsible for over 3,000,000 square feet of buildings for various janitorial contracts at Offutt Air Force Base, Stratcom, Zorinsky Federal Building, and Denney Federal Building in Lincoln. GSSI was also responsible for grounds maintenance for over 25 acres at the VA Hospital in Omaha. GSSI also operates two postal contracts at Offutt Air Force Base serving over 1000 airmen and incoming personnel.

Other Contracts - GSSI's commercial services division provides job opportunities for individuals with barriers to employment. Current contracts include commercial bus cleaning for MAT Bus in Omaha, pressure washing of MAT bus stops, custodial services for private businesses, property management, and grounds maintenance for residential and commercial customers. Individuals are provided full or part time employment depending on their personal preference. Training relative to job requirement is provided to ensure personnel are given an opportunity to understand what is expected of them and to provide a path for professional growth.

In consideration of the services to be performed, the company agrees to pay a Manager fee equivalent to all excess revenue, after meeting operating expenses of the company.

Form 990, Part VI, Section A, Line 6 - GSSI has one member which shall be Goodwill Industries, Inc.

Form 990, Part VI, Section B, Line 11a - Form 990 is prepared based on the audited financial statements of the organization. The completed 990 is provided to the Audit Committee of the Board of Trustees, and to an independent CPA firm who reviews and approves the document and then approval is given for online filing. The 990 return is also sent to the Board of Trustees to provide them an opportunity for inquiry. The Audit Committee Chairman reports its activities and results to the Board of Trustees at its next meeting, and this report is included in the meeting minutes.

Form 990, Part VI, Section B, Line 12c - A signed conflict of interest statement is obtained from each officer, member of the Board of Trustees, and key employees of the organization. Each statement documents direct business relationships, family business relationships, and inter and intra family and business relationships. For any official action of the Board or its committees, any individuals with whom a conflict may be construed, are precluded from voting.

Form 990, Part VI, Section B, Line 15 - GSSI does not have any employees, however, GWI's Executive Committee of the Board of Trustees appoints an Executive Compensation Committee to review and evaluate the compensation of the President and CEO as well as the 7 Vice Presidents. Since 2006, the Compensation Committee has retained a professional compensation, benefits, and human resources consulting firm to assess the reasonableness and competitiveness of total cash compensation. Comparability data is assembled from a variety of sources, including regional IRS Form 990 data, Goodwill Industries International survey data, national not-for-profit published survey data, and the national for-profit published survey data. Based on the results of the assessment study, the Compensation Committee recommends to the Board of Trustees compensation levels for the President and Vice Presidents. These levels are approved in the executive session of the Board of Trustees at its annual meeting in January each year.
