Goodwill operates 17 retail stores open to the public in Omaha (10), Fremont (1), Blair (1), Gretna (1), Bellevue (1), Papillion (2), and Council Bluffs, Iowa (1). The general public donates clothing, furniture, and household goods to Goodwill. Goodwill employees sort, price, and distribute merchandise for sale in the retail stores. Merchandise that does not sell within a reasonable time in the stores is transferred to the Goodwill WearHouse store where it is offered for sale at a specified price per pound. Goods determined not to be saleable in the Goodwill stores are "salvaged" and sold to third parties, who either ship and sell the goods to third parties or recycle them for their textile, metal, or other recyclable materials. Goodwill profits generated from the sale of donated goods help cover expenses associated with Goodwill's mission programs that serve the community.

WORKFORCE DEVELOPMENT PROGRAM SERVICES - Goodwill provides educational and career services, job placement and post-employment support to individuals with disabilities and other challenges to employment so they can find and keep jobs. Individuals receive training and education, work experience, employment placement, and follow-up services through these programs. Goodwill programs strengthen our community by forming a pathway towards success for those who have not been able to find or maintain employment on their own.
