GSSI IS CURRENTLY ENGAGED IN CUSTODIAL, POSTAL SERVICES AND GROUNDS MAINTENANCE CONTRACTS THROUGH THIS PROGRAM. EMPLOYEES ARE PAID THROUGH A MANAGEMENT AND ADMINISTRATIVE SERVICES CONTRACT WITH GOODWILL INDUSTRIES INC.
